

# Extending A Fair, Urgent Request

Since we entered into formal ministry service in 2,000 A.D. as “Endurance Ministries,” we have tried to approach *addressing false matters* in this way: We contact those who are directly tied to the view we are confronting when we can find the contact information needed to do so. We have been writing to individuals, churches and ministries (respectfully raising concerns as the Lord leads us) **before** taking the matter public, especially if the appeal is an end-time *teaching* in conflict with the explicit data in God’s Word.

We believe this fair approach honors some biblical principles, especially as it relates to treating Family members in Christ and others in ways consistent with Bible Truths. To date, very few have responded to our communications. We won’t list those (whom we have contacted) here in this article. Instead, we’d like to ask for similar treatment from those who comment on our appeals.

We ask for (what we sincerely believe to be) fair treatment from those who contend against us and from those who have questions and/or comments about our ministry efforts. PLEASE, if you have response comments, questions, etc., about the end-time views we publish, **contact us** before going public with your criticisms, etc. We are most approachable and have clearly posted means to get in contact with us. We make this request for multiple reasons, one of which includes genuine care for those who respond. Let me further explain using an example.

Some have misrepresented *The Final Trumpet Rapture Gathering* position over the years. IF these folks who have done so had simply contacted us and discussed some of their concerns before going more vocal (i.e., public) about their opposition, some of the issues would have been dropped (due to *faulty* understanding of the position we espouse) and no serious embarrassment on their part would have occurred.

FACT: To date, we have responded to everyone\* who has taken the time to contact us. This, too, is factual: There has not been ONE explicit **Bible-based** rebuttal to the biblical end-time position we put forth for prayerful and exegetical consideration (not that has been communicated to us, anyway). A few have written and we have responded. If you don’t agree with these factual claims, please contact us so we can *talk it over*. “Thank you” in advance.
